Progress in the preparation of country reports

We are pleased to announce that Country Reports which will provide an overview and analysis of data on gender-based violence and the use of trauma-based assistance and support systems in partner countries have just been completed.

The aim of these reports is to collect and analyse available data related to the access to justice of gender-based violence survivors and to provide detailed mapping of available victims' support services/methodologies and best practices which implement a TIC approach. The collection and the analysis of data will use institutional sources (e.g. national statistical institutes, etc.), as well as literature review of relevant publications at national and European levels.

The reports will soon be disseminated and posted on partners websites and project social media accounts.

Second coordination meeting of partners

Autonomous Women's House Zagreb hosted the second coordination meeting of partners in #Care4Trauma project, held in Zagreb on November 16 2022 in the premises of the Center for Women's Studies. During the meeting the main issues in project implementation so far were discussed and the activities that will be implemented in the next 6 months were discussed in detail.

In the afternoon of the same day a mutual learning event was organized with members of Women's Network of Croatia (Ženska Mreža Hrvatske), during which project partners had the opportunity to discuss the state of women's rights and key issues faced by each country. At the end of the meeting the work of Croatian feminist writer and journalist Marija Jurić Zagorka was presented to meeting participants.

It was decided that the next Steering Committee Meeting will take place on 17th May 2023 in Tartu (Estonia).

Activities for the next six months

Data Report on Assessment Survey: online questionnaires and structured interviews with relevant representatives of institutions will be carried out by **March 2023**.

Draft Policy Recommendations will be streaming from the national Country and Data Reports and will summarise main trans-national issues—by **April 2023**.

Consultation Workshops: draft Policy Report has to be discussed with the personnel of shelters and organizations providing support to victims of GBV—by **April 2023**.

State of Art and Policy Recommendations Report will incorporate the feedback from the Consultation Workshops. The deadline for this task is **May 2023**.

Training of Trainers Curricula will be developed by **May 2023**.

Training of Trainers in Bologna will take place on the following dates:

ToT for social workers: from 5 to 9 June 2023

ToT for psychologist: from 12 to 16 June 2023.
